JOB ANNOUNCEMENT

COMMUNITY ADVOCACY PROGRAM TEEN ADVOCATE

Domestic violence survivors and people of color strongly encouraged to apply

- RESPONSIBILITIES:** Provides mobile, culturally competent, and trauma informed supportive services and prevention education to teens experiencing intimate partner abuse. Consults with youth-serving professionals, school faculty, parents and other relevant support systems as appropriate.
- REPORTS TO:** Community Advocacy Program Manager
- HOURS:** 36 hours per week; Monday-Friday business hours, with up to one regularly scheduled evening per week.
- COMPENSATION:** \$19 per hour, medical, dental, life and vision benefits; retirement contribution; paid time off and monthly paid training; training allowance. This is a non-exempt position.

RESPONSIBILITIES:

Supportive Services

- Provides mobile, trauma-informed emotional support, crisis intervention, safety planning, appointment accompaniment, referrals and individual case advocacy for teens experiencing intimate partner abuse.
- Incorporates healthy relationships/domestic violence prevention education into supportive services with teen survivors, collaborating closely with New Beginnings' Prevention Educator to ensure methods reflect best practices.
- Consults with, and provides technical assistance and training on teen intimate partner abuse to youth-serving professionals.
- Advocates with and provides education about dating abuse to parents of teens experiencing intimate partner abuse.
- Facilitates one or more teen support groups.
- Collaborates with the Prevention Educator to identify and support teens interested in serving as peer leaders on dating abuse prevention and intervention.
- Develops and distributes Teen Advocacy Project promotional materials.
- Provides back-up facilitation of healthy relationships workshops with teens as work flow allows.
- Staffs at least one Help Line shift during business hours each month.
- Coordinates interpreter or ASL services for non-English speaking or hearing impaired teens.
- Performs other duties as assigned.

Data Integrity

- Enters consistently complete, accurate and appropriate participant and service data into the agency database.
- Responds to meet data needs identified by the Program Manager or data staff.

Community Networking

- Maintains extensive knowledge of community resources for the benefit of teen survivors, actively promoting New Beginnings' teen advocacy services within relevant circles.

- Assists with identifying new partners for New Beginnings' provision of services to teen survivors.
- Attends community meetings as requested by the Program Manager.

Resource Development

- Participates in development events and activities as requested by the Program Manager.
- Provides program information and stories as needed by the development team to build donor support and pursue funding opportunities.

Team Work and Professional Development

- Actively contributes to a positive team environment to ensure the collaboration needed for provision of high quality services to survivors.
- Participates in all staff meetings, Community Advocacy Program team meetings, planning days and agency in-service trainings.
- Attends and documents trainings to ensure compliance with Washington Administrative Code training requirements for domestic violence advocates.

QUALIFICATIONS:

- Commitment to the mission of New Beginnings and to the needs to domestic violence survivors.
- At least two years of experience providing survivor-centered advocacy to teens and/or young adults. Related experience in non-domestic violence agency settings will be considered.
- Knowledge about the dynamics of intimate partner abuse in teens.
- Demonstrated ability to work with diverse young people in a welcoming, supportive, culturally competent manner.
- Ability to relate well to teens, including strong familiarity with teen pop culture, social media and other trends.
- Ability to navigate teen-parent relationships with sensitivity and professionalism.
- Understanding of adolescent developmental stages.
- Experience providing consultation and technical assistance to human service and/or education professionals a plus.
- Experience with facilitating teen workshops a plus.
- Experience with mobile advocacy a plus.
- Knowledge of a wide range of community resources to meet variable teen survivor needs.
- Demonstrated ability to exercise flexibility and creativity in helping teen survivors overcome a variety of barriers to well-being and stability.
- Ability to take initiative, and maintain accountability to colleagues while providing services in a variety of settings.
- Demonstrated ability to handle crises and juggle multiple responsibilities in a fast-paced environment.
- Ability to maintain participant confidentiality.
- Ability to effectively network with a wide range of community service providers.
- Strong attention to detail and follow-through.
- Ability to represent New Beginnings in a professional manner to community partners and the broader public.
- Ability to use supervision effectively to gain support and enhance performance.
- Ability to engage in constructive self-care activities to manage secondary trauma.
- Proficient with Microsoft Office applications.
- Fluency in Spanish, African or Asian languages a plus.
- Possession of a valid Washington State driver's license. Access to reliable personal car a plus.
